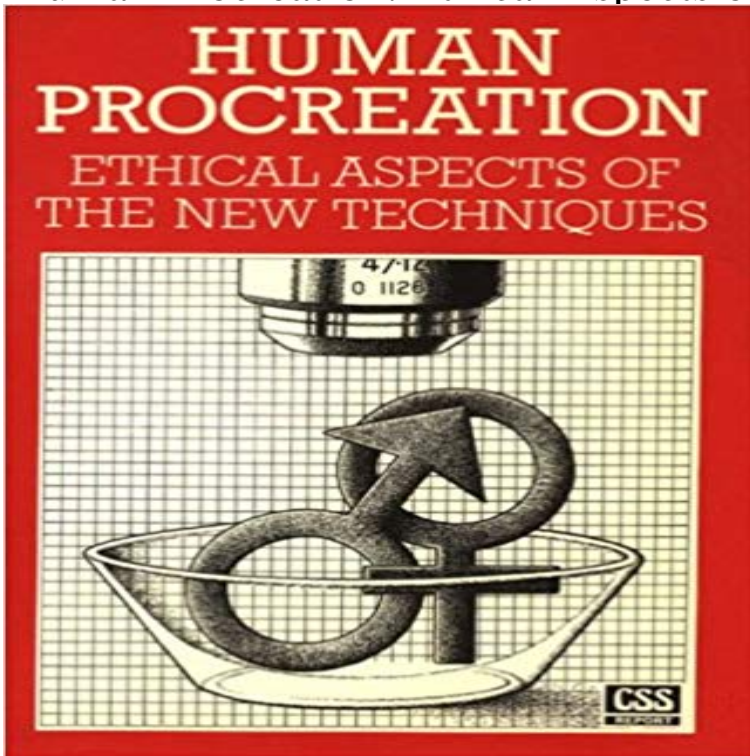


Human Procreation: Ethical Aspects of the New Techniques
